Should the member choose to not renew their membership, a written statement of postponement will be needed (30) days prior to the non-renewing of membership. Upon returning to the club and membership privileges a written statement of reinstatement will be needed (15) days prior to membership becoming active.

Will also be eligible for \$10 lesson group clinics and discounted private lessons, Adult- \$40 per hour/\$20 half hour, Junior- \$30 per hour/\$20 half hour.
- Raven Gold \$500 initiation/\$119 monthly**
 - Monthly membership entitles member, spouse, and dependents* to unlimited green fees and golf car at Raven Nest Golf Club. Will also be eligible for \$10 lesson group clinics and discounted private lessons, Adult- \$40 per hour/\$20 half hour, Junior- \$30 per hour/\$20 half hour.
- Raven Silver \$500 initiation/\$89 monthly**
 - Monthly membership entitles member, spouse, and dependents* to unlimited green fees at Raven Nest Golf Club. Will also be eligible for \$10 lesson group clinics and discounted private lessons, Adult- \$40 per hour/\$20 half hour, Junior- \$30 per hour/\$20 half hour.
- SHSU Student \$399 semester**
 - Semester membership valid for Sam Houston State University Students only. Must present a valid semester schedule to be eligible. Entitles member only to unlimited green fees and golf car fees.

Membership Rules & Regulations

- Members, spouses, and dependents in good standing have the full use of all Club facilities at any time during business hours. They may reserve starting times up to one week in advance for weekday/weekend and holiday play (Sunday-Saturday) Member, spouse, and dependent are defined as:
 - Member** – Individual over the age of 18 who has signed a membership contract.
 - Spouse** – Individual married to a member or a significant partner living in the same household as the member.
 - Dependent** – Member’s natural or adopted child or stepchild under the age of 19; to be eligible between the ages of 19-24, the dependent’s primary residence must be that of the member or must be a full-time student.
- Members must abide by all Raven Nest Golf Club’s rules and regulations, including but not limited to:
 - Dress Code – Proper golf clothing is required.
 - Damages – Any damage to the golf club property by a member, spouse, or dependent shall be the responsibility of the member.
 - Registration – All members must check in to the golf shop prior to use of the facilities.
 - Restrictions – No members are allowed in cart barn or behind Pro Shop counter, for safety and liability reasons.
